

ABOUT TRAFFIC FINES

Within 30 days of issue of your citation your payment is due. If you fail to pay, make payment arrangements or contest your citation in court within 30 days, your driver's license will be suspended.

If you pay for your citation or are adjudicated guilty you may incur points on your license.

Traffic Violation	Points Assessed
Moving	3 points
Speeding 15 mph or less	3 points
Speeding 16 mph or more	4 points
Red Light	4 points (mandatory 4-hr school)
Passing a stopped school bus	4 points (mandatory 4-hr school)
Moving Violation (non speeding) w/crash	4 points
Unlawful Speed s/crash	6 points
Reckless Driving (criminal traffic)	4 points
Leaving scene of crash >\$50.00 damage	6 points
Littering	3 points (regardless of withhold)

MANDATORY COURT APPEARANCE

If your citation indicates a court appearance is required, you can request a hearing from the Lee County Clerk of Courts.

PROOF OF CURRENT DOCUMENTS

If you were unable to provide proof of a current Driver's License, Insurance or Vehicle Registration you can provide proof of current documents to the Lee County Clerk of Courts and the Violation will be DISMISSED for a fee.

VOLUNTARY PAYMENT

If you pay your fine it counts as an adjudication (guilty). Voluntary payment for Suspended unknowingly counts as adjudication and possible suspension of your license. Late fine payments could result in a 40% increase in fine amount.

TRAFFIC SCHOOL

If you elect traffic school points will not be assessed against your license. School election increased the civil penalty by \$7 plus any additional fees assessed by your traffic school of choice. Drivers with Commercial Driver License (CDL) are not eligible to attend traffic school to avoid points.

When paying for your citation elect the traffic school option if it is available to you.

ENROLLING IN TRAFFIC SCHOOL

Contact the Traffic School of your choice. For a list of traffic schools you can refer to www.leeclerk.org or www.flhsmv.gov

You must submit the school completion certificate **with the citation number on the face of the certification** to the clerk of courts at www.TrafficSchoolCompletions@leeClerk.org

ATTENTION

If you elect traffic school and fail to attend, or if you turn in your school certificate late, you will be assessed additional fees, points and driver license suspension. Contact the Lee County Clerk of Courts FLDHSMV for more information.
