As a result of a report issued by a concerned citizen, Lee County Sheriff's Office deputies responded to allegations that an Estero resident had been video recorded "striking and choking" his dog; a five-monthold Golden Doodle named "Benjamin."



Following multiple interviews and review of video, it was determined that probable cause did exist and Chad Pierson Perrow (DOB 07-28-1986) was arrested for misdemeanor animal cruelty, a violation of F.S.S. 828.12-1.

Benjamin was impounded for veterinary examination.

### Summer Shorebird Stewarding

Each summer, from May through August, shorebirds like Least Terns, Black Skimmers and Plovers nest along our beaches. Bird Stewards are on the front lines, helping these birds succeed in one of the most challenging seasons of their lives.

### Stewards work weekends and holidays at two key nesting sites:

Southern Fort Myers Beach (Carlos Pointe)

Cayo Costa State Park

### What Do Shorebird Stewards Do?

Educate the public about the birds and how to avoid disturbing nesting areas.

Offer views through spotting scopes so people can safely watch natural behaviors like chick feeding and courtship displays.

Collect important data on nesting activity, banded birds, and disturbances.

Serve as ambassadors for shorebird conservation and help foster appreciation for native coastal species.

# Blue Ridge Beef Issues Voluntary Recall of Blue Ridge Beef Puppy Mix and Kitten Mix Due to Salmonella & Listeria Contamination.

STATESVILLE, NC — Blue Ridge Beef is recalling 1,080 lbs. of their 2 lb. logs of Kitten Mix Lot # N26 0114 and 1,380 lbs. of their 2 lb. logs of Puppy Mix Lot # N25 1230 (Lot numbers are stamped in the clips on the end of the chubs/bags) due to contamination with Salmonella and Listeria.

Salmonella and Listeria can affect animals eating the products and there is risk to humans from handling contaminated pet products, especially if they have not thoroughly washed their hands after having contact with the products or any surfaces exposed to these products.

Healthy people infected with Salmonella or Listeria should monitor themselves for some or all of the following symptoms: nausea, vomiting, diarrhea or bloody diarrhea, abdominal cramping and fever. Rarely, Salmonella and Listeria can result in more serious ailments, including arterial infections, endocarditis, arthritis, muscle pain, eye irritation, and urinary tract symptoms. Consumers exhibiting these signs after having contact with this product should contact their healthcare providers.

Pets with Salmonella or Listeria infections may be lethargic and have diarrhea or bloody diarrhea, fever and vomiting. Some pets will have only decreased appetite, fever and abdominal pain. Infected but otherwise healthy pets can be carriers and infect other animals or humans. If your pet has consumed the recalled product(s) and has these symptoms, please contact your veterinarian.

The products were distributed between January 3, 2025 and January 24, 2025.

Due to a customer complaint of animal illness, samples of the products were collected on March 20, 2025 by the New York State Department of Agriculture and Markets. On April 1, 2025, the firm was notified by the North Carolina Department of Agriculture that the products tested positive for Salmonella and Listeria.

Products affected are:

BLUE RIDGE BEEF PUPPY MIX 2LB LOT NUMBER: N25 1230

BLUE RIDGE BEEF KITTEN MIX 2LB LOT NUMBER: N26 0114

Consumers who have purchased these products are urged to return them to the place of purchase or destroy the food in a way that children, pets, and wildlife cannot access. Do not sell or donate the recalled products. Do not feed the recalled product to pets or any other animals. Wash and sanitize pet food bowls, cups, and storage containers. Always ensure you wash and sanitize your hands after handling recalled food or any utensils that come in contact with recalled food. 


### ANIMAL CRUELTY/HUMAN VIOLENCE AWARENESS WEEK

April 21, 2025, begins a week of awareness linking the mistreatment and abuse of people and cruelty to animals.

If you're unaware of the "link," please read on...

- People who hurt, injure and abuse animals DO NOT limit their violence towards animals.
- Numerous, detailed studies have shown a strong link between animal abuse/cruelty and a cycle of violence against humans.
- Animal abuse is considered a "predictor crime."
  "Predictive Policing" uses analytical data to predict likely violence.
- Child safety experts indicate that when animals are abused in the home, it is likely an unsafe environment for children. A 1983 study showed that animals were abused in 88% of homes where there was documented child abuse.
- Children who witness animal abuse can experience emotional and behavioral problems and become desensitized to violence.
- Animal abuse and cruelty are also strongly linked to domestic violence.
- A 1997 study by the Massachusetts Society for the Prevention of Cruelty to Animals and Northeastern University found that animal abusers are FIVE TIMES more likely to also harm other humans.



### (Animal Cruelty / Human Awareness week...continued)

- Abuse of a partner's pet is a method of control and intimidation.
- Studies show that up to 71% of battered women have reported that their pets have been threatened, harmed or killed by their partners.
- Studies also indicate that a significant number of women avoid or delay leaving a domestic violence situation out of concern for their pets' safety.

All canines and felines were initially checked to see if they were already microchipped and, if not, they were


chipped at no cost.

home when chipped. Please ensure that your pets are all microchipped!












# IN LOVING MEMORY
